

Metropolitan Market 2026 WA August Winemaker Picnic Promotional Game of Chance

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THE PRIZE. VOID WHERE PROHIBITED.

1. **Sponsor:** The Sponsor of the Metropolitan Market 2026 WA August Winemaker Picnic Promotional Game of Chance ("Promotion") is Metropolitan Market, LLC, 1500 114TH Avenue SE, Bellevue, WA 98004, USA ("Sponsor").
2. **Eligibility:** The Promotion is open and offered only to legal residents of Washington, who are at least twenty-one (21) years of age, and have the ability to travel to and participate in the Auction of Washington Wines Winemaker Picnic. Employees of Sponsor, Auction of Washington Wines, Washington Wine Commission, and their immediate families (parent, child, sibling, or spouse) and/or household members of respective parent companies, subsidiaries, affiliates, distributors, sales representatives, advertising and promotional agencies, and any other persons or entities associated with this promotion are not eligible to participate in the Promotion. The Promotion is subject to all applicable federal, state, and local laws and regulations, and is void outside the United States and where prohibited.
3. **Agreement to Official Rules:** By participating in the Promotion, Entrant agrees to be fully and unconditionally bound by these official Promotion rules ("Official Rules"), and Entrant represents and warrants that they meet the eligibility requirements. In addition, Entrant agrees to accept the decisions of Sponsor as final and binding as it relates to this Promotion and consents to be contacted by Sponsor by email.
4. **Promotion Period:** Digital entries only. Promotion begins on Friday, July 10, 2026 at 12:01am Pacific Standard Time ("PST") and ends on Thursday, August 6, 2026 at 11:59pm, PDT (the "Promotion Period"). All entries must be received during the Promotion Period. Sponsor's computer (or that of its designee for this Promotion) is the official time keeping device for online entry into the Promotion.
5. **How to Enter:** To enter, Entrant must visit the Metropolitan Market website landing page at <https://www.metropolitan-market.com/waugust-giveaway> and complete the online entry form by providing their first and last name and email address, and opt in to receive promotional emails. Entrant may also voluntarily provide a mobile telephone number and opt in to receive recurring automated marketing and promotional text messages (SMS) from Sponsor, as described in Section 6 (SMS Marketing Opt-In) below. Providing a mobile telephone number and opting in to receive SMS messages is optional and not required to enter the Promotion or to be eligible to win the Prize. The entry must be complete and eligibility must fulfill all Promotion requirements, as specified in these Official Rules, to be eligible to win the Prize. Selected Winner must be verified in person and must present a valid Washington ID card. Entries that are incomplete or do not adhere to these Official Rules may be disqualified at the sole discretion of Sponsor. Entrant may enter only once.

Entrant must provide the information requested. Entrant may not enter more than once by using multiple email addresses, identities, or devices in an attempt to circumvent the Official Rules. By submitting an entry, Entrant represents and warrants that all information provided as part of their entry is accurate, does not violate any third party's legal rights (including without limitation rights of privacy and publicity), and otherwise does not violate applicable law.

6. SMS Marketing Opt-In (Optional): As part of the online entry form, Entrant may choose to opt in to receive recurring automated marketing and promotional text messages (SMS) from Metropolitan Market, LLC ("Sponsor") by providing a valid mobile telephone number and affirmatively checking the SMS opt-in box. These messages may include information about Sponsor's products, promotions, offers, events, and similar marketing communications. Opting in to receive SMS messages is voluntary. Consent to receive SMS marketing messages is not a condition of entering the Promotion, of eligibility to win the Prize, or of purchasing any property, goods, or services, and an Entrant's decision to opt in or to decline has no effect on the Entrant's odds of winning. By opting in, Entrant authorizes Sponsor and its service providers to deliver marketing and promotional text messages to the mobile telephone number provided using an automatic telephone dialing system or other automated technology. Neither Sponsor nor the wireless carriers are responsible for delayed or undelivered messages. Entrant represents and warrants that the mobile telephone number provided belongs to Entrant and that Entrant is authorized to opt in to receive messages at that number. Phone numbers and SMS marketing consent are collected, used, stored, and protected in accordance with the Sponsor's Privacy Policy and any applicable SMS program terms contained in the Terms and Conditions referenced on the Sponsor's website and in the Privacy Policy section below.
7. Prize: The selected winner of the Promotion (the "Selected Winner") will be given the "Prize," which is two (2) Shade & Seat Tickets to the Winemaker Picnic August 14, 2026 at Chateau Ste Michelle at 5pm, 14111 NE 145th Street Woodinville, WA 98072 . Any and all Prize-related expenses, including without limitation transportation costs, shall be the sole responsibility of Selected Winner. The winning of the Prize is a taxable event, and if the prize is \$600 or more, the Selected Winner will receive a tax for 1099 and will be required to provide their social security number. No substitution of Prize or transfer/assignment of Prize to others or request for any special privilege by Selected Winner is permitted, except by Sponsor, who reserves the right to substitute the prize for something of equal or greater value for any reason. Acceptance of Prize constitutes permission for Sponsor to use Selected Winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law. Prize is awarded "AS IS" with no warranty, representation or guarantee, express or implied, in fact or in law, made by Sponsor or for which Sponsor shall be liable, including, without

limitation, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, NONINFRINGEMENT OR FITNESS FOR A PARTICULAR PURPOSE.

8. Odds: The odds of winning depend on the number of eligible entries received by Sponsor.
9. Selected Winner Selection and Notification: On or about August 7, 2026 one (1) Selected Winner will be chosen by a random drawing by or under the supervision of Sponsor from among all eligible entries received by Sponsor. The Selected Winner will be notified within forty-eight (48) hours following selection of the Selected Winner, by email. Sponsor shall have no liability for the Selected Winner's failure to review messages or email notices from Sponsor due to SPAM filters, telephone block systems or other technology challenges or security settings or for the Selected Winner's provision of incorrect or otherwise non-functioning contact information. **Selected Winner will have 48 hours to reply by email only.** If the Selected Winner cannot be contacted, is ineligible, or fails to claim the Prize within 48 hours, the Prize may be forfeited and no alternate Selected Winner will be required to be selected by Sponsor. Receipt by the Selected Winner of the Prize offered in this Promotion is conditioned upon compliance with any and all federal, state, and local laws and regulations.  - The ARV of the Prize (2 tickets) is \$450.00.
11. Prize Delivery: Once Selected Winner has been confirmed, he or she will receive an email containing digital tickets which will be used to enter the event. Selected winner and guest will be required to show valid Washington ID card at the event to verify they are 21+. Tickets will not be replaced in the event they are inadvertently deleted or sent to an email address provided by the winner that is misdirected.
 12. Declaration of Eligibility: The Selected Winner may be required to execute and return to the Sponsor a declaration of eligibility (the "Declaration"), and Selected Winner must provide a valid Washington ID card, in person, to claim the prize. By completing, signing and returning the Declaration, the Selected Winner (i) releases and forever discharges the Sponsor, its affiliates and subsidiaries, and their respective advertising and promotional agencies from all claims, demands, damages, actions and causes of action arising out of

participation in this Promotion or to arise by use of the Prize, and (ii) confirms compliance with these Official Rules. If the Selected Winner is unable or unwilling to complete the Declaration in its entirety, Selected Winner forfeits the Prize.

13. Taxes: All taxes associated with the Prize are the sole responsibility of the Selected Winner.
14. Terms & Conditions: Sponsor reserves the right to correct typographical errors that may result in unintended interpretations of these rules. Sponsor also reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Promotion should a pandemic, public health emergency, computer virus or bug, non-authorized human intervention, fraud, or other cause beyond Sponsor's control corrupt or affect the administration, security, fairness, or proper conduct of the Promotion. In such case, Sponsor may select the Selected Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Sponsor. Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Promotion or website or violates these Official Rules. Sponsor has the right, in its sole discretion, to maintain the integrity of the Promotion, to void entries for any reason, including, but not limited to: (a) multiple entries from the same user from different IP addresses; (b) multiple entries; or (c) the use of bots, macros, scripts, or other technical means for entering. Any attempt by an individual to deliberately damage any website or undermine the legitimate operation of the Promotion may be a violation of criminal and civil laws. Should such attempt be made, Sponsor reserves the right to seek damages to the fullest extent permitted by law. Guest must be at least twenty-one (21) years old at the time of the Event. Winner and guest must comply with all Sponsor's, venue, and event rules.
15. Limitation of Liability: By entering, Entrant agrees to release and hold harmless Sponsor, Washington State Wine Commission, and their subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers, and directors from any liability, illness, injury, death, loss, litigation, claim, or damage that may occur, directly or indirectly, whether caused by negligence or not, from: (i) Entrant's participation in the Promotion and/or Entrant's acceptance, possession, use, or misuse of the Prize or any portion thereof; (ii) technical failures of any kind, including but not limited to the malfunction of any computer, cable, network, hardware, or software, or other mechanical equipment; (iii) the unavailability or inaccessibility of any transmissions, telephone, or Internet service; (iv) unauthorized human intervention in any part of the entry process or the Promotion; (v) electronic or human error in the administration of the Promotion or the processing of entries; and (vi) participation in any Prize-related activity (including, without limitation, claims, costs, injuries, losses or damages related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation or portrayal in a false light).
16. Disputes: THIS PROMOTION IS GOVERNED BY THE LAWS OF THE STATE OF WASHINGTON,

WITHOUT RESPECT TO CONFLICT OF LAW DOCTRINES. As a condition of participating in the Promotion, Entrant agrees that the only remedy for dispute relating to the Promotion is an entry. Any disputes relating to the receipt of the Prize that cannot be resolved between Entrant and the Sponsor, shall be resolved individually, without resort to any form of class action, exclusively before a court of competent jurisdiction located in King County, WA. Further, in any such dispute, under no circumstances shall Entrant be permitted to obtain awards for, and Entrant hereby waives all rights to, punitive, incidental, or consequential damages, including reasonable attorney's fees, other than Entrant's actual out-of-pocket expenses (i.e., costs associated with entering this Promotion). Entrant further waives all rights to have damages multiplied or increased.

17. Privacy Policy: Information submitted by Entrant in connection with the Promotion is subject to the Privacy Policy stated on the Sponsor website. To read the Privacy Policy, Entrant may visit [Metropolitan Market Privacy Policy](#). All personal information collected by Sponsor will be used for administration of the Promotion. In addition, independent of the Privacy Policy, Entrants may receive email correspondence from, or on behalf of Sponsor. Sponsor uses reasonable commercial efforts to comply with Federal CAN-SPAM guidelines and to supply information to entities that comply with CAN-SPAM guidelines, and Entrants may subsequently opt-out of receiving further emails by following the opt-out instructions contained in the email. Entrants who voluntarily provide a mobile telephone number and opt in to receive SMS marketing messages (see Section 6 above) may subsequently opt out of receiving further text messages at any time by replying STOP to any message; mobile telephone numbers and SMS marketing consent are collected, used, stored, and protected in accordance with the Sponsor's Privacy Policy and any applicable SMS program terms contained in the Terms and Conditions on Sponsor's website.
